## 2 Qualifications

## Qualifications

### 1. Musician

O Applicants must major in relevant instruments.

### \* Recognized experiences

- Experiences in national, municipal and public arts group, professional arts corporations, or performance-related institutions or organizations operated by national municipalities are recognized.

### 3. Common qualifications

- Candidates should work at all times.
- Candidates who have not violated the Article 31 of the Local Public Service Act.
- Candidates who have not been disciplined within last 3 years by national or public organizations.
- Candidates should be under 55 years old.

#### **\* Local Public Officials Article 31(Grounds for Disqualification)**

Any Person who falls under the following subparagraphs may not be appointed as a public official:

- 1. A person declared incompetent or quasi-incompetent;
- 2. A person declared bankrupt and has not yet been reinstated;
- 3. A person sentenced to imprisonment without prison labor or heavier punishment and completed the sentence or for whom five years have not passed since the final decision of exemption from execution of such sentence;
- 4. A person sentenced to punishment of imprisonment without prison labor or heavier punishment and for whom two years have not passed since the expiration of the period of suspension of execution;
- 5. A person under the period of suspended sentence of a punishment heavier than imprisonment without prison labor;
- 6. A person disqualified, or whose qualification in suspended, pursuant to a decision of a court of other Acts;
- 6-2 A person who commits any offense prescribed by Article 355 and 356 of the Criminal Act while in office as a public official, and is punished by a fine not less than 3 million won, and for whom two years have not passed after his/her sentence is finalized;
- A person removed from his/her office by a disciplinary action, and for whom five years have not passed thereafter;
- 8. A person dismissed by a disciplinary action, and for whom three years have not passed thereafter.

- 2. The time of performance test will be announced on website of Daejeon Philharmonic Orchestra(www.dpo.or.kr), 8 March 2018 Thursday.
- 3. In case there is no qualified applicant, no applicant may be chosen.
- 4. In case there are more than one candidates who earned the highest credit, the final successful candidate will be determined in the order of applicant from local, applicant with experiences and youngest applicant.
- 5. Successful candidates of  $2^{nd}$  round will be determined within  $2\sim3$  times of recruitment number based on points from  $2^{nd}$  round. Successful candidates will be on 3 months trail in the orchestra. If no candidates pass the  $3^{rd}$  round, a candidate who got the next highest points from the  $2^{nd}$  round will have a chance to have a 3 month orchestra trial.

# 4 Audition Procedure

### 1. Musician

## O 1st round: Document and DVD examination

- Qualifications will be examined based on materials each applicants submit.
- Applicants should submit a performance DVD of a test piece within 10 minutes to demonstrate their skills(no accompaniment). Test pieces will be announced at www.dpo.or.kr.
- Successful candidates will be determined within 10 times of recruitment number based on scores. Successful applicants should exceed a standard of expectation.

### O 2<sup>nd</sup> round: Performance test

- Successful candidates from the 1<sup>st</sup> round will be on the 2<sup>nd</sup> round.
- The list of test pieces and details of audition starting time will be announced at www.dpo.or.kr.
- 2<sup>nd</sup> concertmaster should get over 90 points from the 1<sup>st</sup> round.
- Tutti member should get over 80 points from 1st round.
- The successful applicants are decided by the total score, which will be calculated the average of points from each jury. For the fairness the highest and the lowest points will be not included.

### O 3<sup>rd</sup> round: Orchestra trial

- Successful candidates from the 2<sup>nd</sup> round will be on the 3<sup>rd</sup> round.
- Candidates should have 3 months orchestra trial(temporary member) in the orchestra.
- $2^{nd}$  concertmaster will be picked from the applicants who applied for the position of  $2^{nd}$  concertmaster who exceed over 90 points average and got the highest points.
- Tutti member will be picked from the applicants who applied for the position of the tutti member who exceed over 80 points average and got

the highest points.

- If the successful candidates from the  $2^{nd}$  round fail to pass the orchestra trial round, the next highest candidates from the  $2^{nd}$  will have a change to apply for  $3^{rd}$  round.

### ○ 4<sup>th</sup> round : Interview

- Successful candidates from the 3<sup>rd</sup> round will be on the 4<sup>th</sup> round.
- Personality, expertise, capability, etc will be examined.
- Successful applicant should get above 80 points average.
- Each applicants will be assessed as excellent, normal and poor for each rating factor. Applicants will be disqualifies if they get poor for at least 2 judges.
